Objective

The ability of forests to limit natural processes of degradation and in particular, erosion, are well established. However, it is also recognised that degradation can be a serious problem in forest soils. This is most serious in conditions of unregulated exploitation, but intensively managed forests are also at risk. Management systems driven by short-term cost efficiencies may result in serious damage to soil. It is often not recognised that ecosystem management and specifically soil management is an integral part of sound forest management.

The aim of the workshop is to raise awareness of the impact of forestry practices on soil degradation and on the importance of forest soils for forest productivity. The causes of degradation will be examined and the impact on long-term productivity discussed. The workshop will review national and regional practices and policies for soil protection and propose a common framework to regional policy makers to reduce the risk of soil degradation in planted forest.

This international workshop is being held as part of the FORRISK final conference and the EFI Annual Conference.
